Introduction

These Travel Policies & Terms outline the guidelines, responsibilities, and expectations when working with AnyWhereButHere Travel, LLC. By submitting a travel inquiry, requesting services, or making any payments, clients acknowledge and agree to the policies listed below. These policies are designed to ensure transparency, efficiency, and a smooth planning experience for all parties.

Travel Planning Fee

A travel planning fee is required to begin personalized trip planning. Planning fees start at \$75 for parties of up to six (6) travelers and \$150 for parties of six (6) or more travelers.

All planning deposits are fully refundable after your trip is completed, provided the travel is not canceled. This ensures our time and expertise are reserved for serious travelers while still offering clients complete peace of mind.

This fee covers customized research, itinerary creation, booking support, and ongoing assistance throughout the planning process.

Payments & Deposits

All payments and deposits must be submitted in full and on time to proceed with trip planning and booking services. Failure to submit required payments by stated deadlines may result in delays, pricing changes, or cancellation of services.

Deposits and payments made toward travel services are subject to the terms and conditions of third-party travel suppliers, including airlines, hotels, cruise lines, and tour operators. Any penalties, change fees, or non-refundable charges imposed by suppliers are the responsibility of the client.

Refunds & Cancellations

Travel planning fees are refundable only after the trip has been completed, provided the travel is not canceled. If a client cancels their trip at any point prior to completion, the planning fee becomes non-refundable.

Refunds for travel services, including flights, accommodations, and excursions, are subject to the individual supplier's cancellation and refund policies. Any penalties, cancellation fees, or non-refundable amounts imposed by suppliers are the responsibility of the client.

Client Responsibilities

Clients are responsible for providing accurate and complete information, including traveler names as they appear on government-issued identification, travel dates, preferences, and required documentation. Any errors or omissions may result in additional fees, delays, or denied travel, for which AnyWhereButHere Travel, LLC is not responsible.

Clients are also responsible for reviewing all travel documents, confirmations, and itineraries upon receipt and notifying AnyWhereButHere Travel, LLC of any discrepancies within 24 hours.
